
4. *Terms of Sale.* The sale will be conducted as a public auction to the highest bidder for cash. 
5. *Obligations Secured.* The Deed of Trust executed by DAVID MICHAEL WINDERS AND BRENDA WINDERS, provides that it secures the payment of the indebtedness in the original principal amount of \$217,200.00, and obligations therein described including but not limited to (a) the promissory note; and (b) all renewals and extensions of the note. REVERSE MORTGAGE SOLUTIONS, INC. is the current mortgagee of the note and deed of trust and REVERSE MORTGAGE SOLUTIONS, INC. is mortgage servicer.
