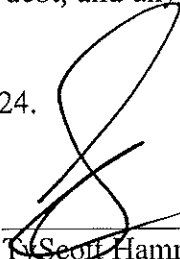

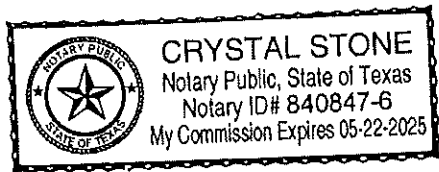


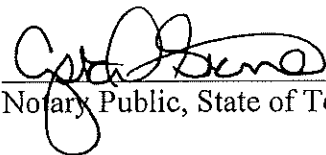

EXHIBIT A

Tract 4

FIELD NOTES for a 10.01 acre tract of land situated League 1, Labor 24, Jones County School Land, Abstract 150, Hockley County, Texas, and more particularly described as follows.

BEGINNING in the north line of said Labor 24 and in Bear Road which bears S. 87° 15' 41" E. a distance of 1020.39 feet from a 1/2" iron rod found at the northwest corner of said Labor 24 for the northwest corner of this tract.

THENCE S. 87° 15' 41" E., along said north line and said Bear Road, a distance of 330.16 feet to the northeast corner of this tract.

THENCE S. 02° 44' 47" W., at 30.0 feet pass a 1/2" iron rod set with a blue cap inscribed "OJD ENG" (hereafter referred to as an OJD cap) in the south margin of said Bear Road, a total distance of 1320.77 feet to an OJD cap set for the southeast corner of this tract.

THENCE N. 87° 15' 41" W. a distance of 330.16 feet to an OJD cap set for the southwest corner of this tract.

THENCE N. 02° 44' 47" E., at 1290.77 feet pass an OJD cap set in said south margin of said Bear Road, a total distance of 1320.77 feet to the POINT OF BEGINNING and containing 10.01 acres of land.
