There being no further business to come before the Court, the Judge declared Court adjourned, subject to call.





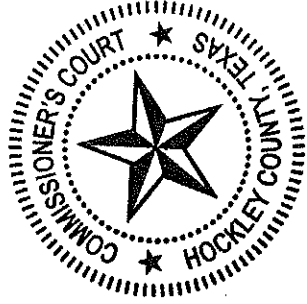
