6. Consider and take necessary action to advertise for sealed bids for LED lighting upgrade.

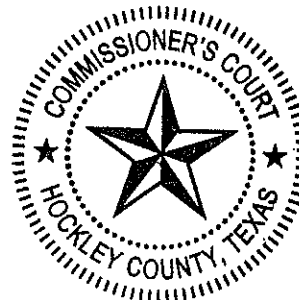

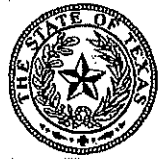


