



Dear Sharla:

The Texas Property Tax Code contains provisions for the governance of our Appraisal District in Section 6.03. It calls for the election of members of the Board of Directors to serve terms beginning with even numbered years. Consequently, we will be conducting the election to fill these positions for the 2022-2023 terms over the next several months.

I wanted to apprise you of this process so your entity will be thinking about who you will nominate and the manner in which you will cast the votes allocated to your entity.

The first step in this election process is the determination of voting entitlements. I have calculated the voting entitlements in accordance with Section 6.03 (e) of the Code and I am sending a copy of my worksheet for your review.

The next step involves the nomination of individuals to serve as directors. Your taxing entity may nominate one individual for each of the five positions to be filled on the Board of Directors by passing a resolution to that effect and submitting it to me on or before October 15, 2021.

The next step is the preparation of the ballot. On or before October 30, 2021 I will prepare a ballot and send it to the presiding officer of your entity's governing body. The governing body will need to pass a resolution casting the entity's votes and submit it to me on or before December 15, 2021. Once I have received the ballots, I will determine the winners and notify each entity of the results of the election on or before December 31, 2021.

I usually receive calls after mailing this letter asking who is presently serving on this Board. So you will know, our board is comprised of Larry Carter (*President*), Ronnie Watkins (*Vice-President*), Buddy Moore (*Secretary*), DeEtte Edens (*Member*), and David Albus (*Member*). You may have other questions or concerns relative to this process. You can reach me during regular office hours at 894-9654. I will be happy to respond to any questions you might have.
