

#### Hockley County and Ropes ISD Joint Elections Agreement

WHEREAS, Hockley County (County) and Ropes ISD (RISD) are each political subdivisions in the State of Texas.

WHEREAS, Governor Abbott has ordered the Special Election on November 4, 2025.

WHEREAS, the Ropes Independent School District's Board of Trustees have ordered a Special Bond Election on November 4, 2025.

WHEREAS, Texas Election Code 271.002(a) authorizes the governing bodies of political subdivisions to enter into an agreement to hold joint elections in election precincts that can be served as a common polling place.

WHEREAS, in the case of a political subdivision that is a school district, a joint election is to be conducted with one or more municipalities and/or with Hockley\_County in compliance with the requirements for school districts as set forth in Texas Education Code 11.0581.

**NOW THEREFORE,** Hockley County and Ropes ISD enter into a Joint Elections Agreement for November 4, 2025, set forth below, acting by and through the Hockley County Commissioners Court and the Ropes ISD Board of Trustees.

#### 1. Legal Documents-

a. Hockley County Elections Administrator (EA), Jody Rose, will post and publish all Orders and Notices relevant to Hockley County Voters for the General Election and RISD Election.

#### 2. Early Voting

- a. Early Voting for RISD Hockley County Voters will be conducted at Ropesville City Hall, 107 Hockley Main in Ropesville from 8:00 am to 5:00 pm during Early Voting. Early Voting will also be available at Hockley County Election Office 911 Austin St. in Levelland TX, from 8:30 am to 5:30 pm M-F, Oct. 21-29 and 7:00 am to 7:00 pm on Oct. 30 and 31.
- b. RISD has appointed Jody Rose as Early Voting Clerk for its Hockley County Voters.
- c. Ballot by Mail applications for RISD's Hockley County Voters for the General Election shall be processed by the Hockley County Elections Office.
- d. Any ballot by mail request received by RISD Hockley County Voters must be forwarded immediately to the Hockley County Elections Office.
- e. RISD will share deputy early voting clerks with Hockley County.
- f. RISD will be required to reimburse Hockley County for half of all early voting clerks at their standard hourly rate.

#### 3. Election Day

a. RISD District boundaries in Hockley County are located in Hockley County

- Precincts, 14, 15, 16 & 21. RISD will share the Election Day polling place in Hockley County at Ropesville City Hall.
- b. Election Day precincts will be open for voting from 7:00 A.M. to 7:00 P.M. on November 4, 2025.
- c. RISD will use the same Judges, Alternate Judges, and Clerks as Hockley County.
- d. RISD will be required to reimburse Hockley County for half of all Election Day Staff at the standard hourly rate, plus a \$25.00 Judge and Alternate Judge election night delivery expense

#### 4. Election Night

- a. Hockley County Elections Office will be responsible for tabulating RISD Hockley County totals.
- b. RISD will be responsible for providing Hockley County with an email and/or fax number to send Election Night Results by Friday, October 31, 2025.

#### 5. Ballots

- a. RISD voters in Hockley County will receive a joint ballot with the RISD and Hockley County ballot combined.
- b. Hockley County Joint Elections Administrator will order Hockley County and RISD ballots and balloting materials.
- c. RISD will be responsible for reviewing the proofs for the RISD Special Bond Election.
- d. Hockley County will send ballot proofs to RISD Bond Attorney, for approval.
- e. Hockley County will be responsible for having ADA equipment programmed for both RISD Hockley County Voters and Hockley County.
- f. RISD will be responsible for paying for the programming and ordering of its balloting materials.
- g. Ballot boxes will be prepared and shared with Hockley County.

#### 6. After the Election

- a. RISD will be required to conduct the canvass for the RISD Special Bond Election.
- b. Any manual counts requested by the State of Texas will be completed by Hockley County.
- c. Any recounts that will need to be performed for RISD (Hockley County Voters) will be completed by Hockley County.
- d. Retention records for RISD will be kept by Hockley County.

#### 7. Other Provisions

- a. Hockley County will bill RISD for the cost of election workers, programming, printing, election equipment and any other cost associated with RISD's election within 30 days after the election, this will be in addition to the \$500 Annual Election Fee which is paid by RISD annually.
- b. If RISD cancels its election, RISD will be required to pay any cost that were incurred during the period up to the cancellation.

- c. If an attorney is needed by either Political Subdivision, it will be the responsibility of that party to pay such attorney.
- d. RISD is also located in Terry County. Hockley County will not be responsible for any activities for any RISD voters located in those counties.
- e. Any amendment of this Agreement shall not be placed in effect unless it is in writing and signed by both Political Subdivisions.


