RESOLUTION AUTHORIZING COUNTY GRANT

*W*HEREAS, the Program rules require the County in which an Organization is providing home-delivered meal services to make a grant to the Organization, in order for the Organization to be eligible to receive Program grant funds; and

*W*HEREAS, the Program rules require the County to approve the Organization's accounting system or fiscal agent, in order for the Organization to be eligible to receive Program grant funds.

*W*HEREAS, the County recognizes Ashley Scifres \_\_\_\_\_ (Authorized Official) as an official of the Organization.
