### LEVELLAND AREA ENDOWMENT GRANT APPLICATION

#### PROPOSAL NARRATIVE

Veterans Day, originally titled Armistice Day, has been celebrated nationally since 1938 being "dedicated to the cause of world peace" and to honor World War I veterans. In 1954, Congress amended the act by striking the word "Armistice" and inserting "Veterans" thus November 11<sup>th</sup> now became a day to honor American veterans who had been involved in all wars. Unfortunately, we, as a community, have become lax in recognizing our veterans. At the request of a local spouse of a veteran we are wanting to institute an annual public recognition and honoring of the veterans of Hockley County. A committee was formed and the attitude was "we go big or go home" for our veterans. This is a group passionate about our veterans. A breakfast is being planned which will include a special speaker and a representative from Honor Flight who will give a brief presentation. One of our goals is to be able to present a check to Honor Flight to cover the cost for a Hockley County veteran to make that trip. In addition, if any funds remain after all expenses are paid then we would like to set them aside for assisting veterans with emergency needs.

As we are looking at a possible attendance of 500 persons the use of funds would be directed towards our largest cost which will be the meal itself.

The committee consists of four persons. What they bring to the table is experience in event planning and knowing who to contact to participate in either a physically present capacity or by donation. However, possibly the most important aspect is, as stated earlier, their determination to make this event happen because of their passion for our military.

As this is a first year project no other grants have been received or requested at this time. To fund this event, the committee is looking to the community, individuals, businesses, and schools to provide through both financial assistance, donation of services, and participation.

After the breakfast, the committee will meet to review the event for what worked, what should be changed and or added. We will also seek input from persons in the community.

At this time we are planning to make this an annual event. We will be looking in to the possibility of forming a foundation to oversee future events and also the use of funds for assisting veterans. We are losing our World War II, Korean, and even our Vietnam veterans but we have a high number of veterans coming out of our Gulf War period which is still going on. They did not, and do not, serve to be recognized but we want to begin a tradition in which we can, in a small way, thank them for the sacrifice they have made for us.
