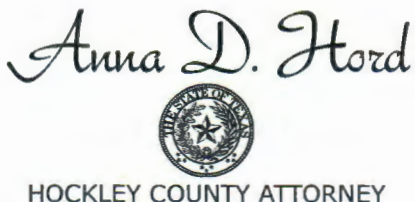

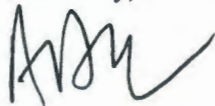
Attached please find a list of cases that have been set for a Docket on **May 05, 2025, at 1:30 p.m.** This will be held in person in the District Courtroom.
