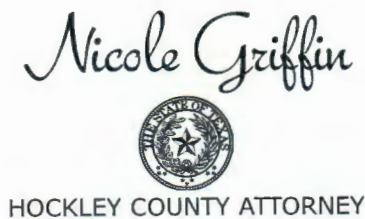


Attached please find a list of cases that have been set for a Docket on **April 15, 2026, at 9:30 a.m.** This will be held in person in the District Courtroom.
