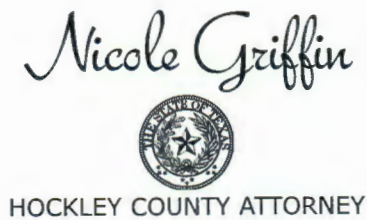


Attached please find a list of cases that have been set for a Docket on **May 18, 2026, at 1: 30 p.m.** This will be held in person in the District Courtroom.
