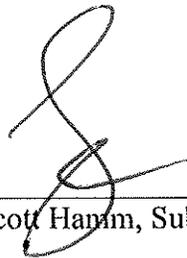

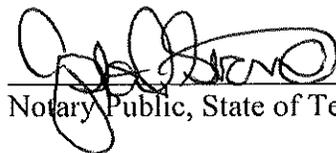

## EXHIBIT "A"

### Tract 1

FIELD NOTES for a 10.28 acre tract of land out of a 160.59 acre tract of land situated in Section 8, Block A, RM Thomson Survey, Abstract 57, Hockley County, Texas, and more particularly described as follows:

BEGINNING at a 1/2" iron rod found in Leon Road at the northwest corner of said Section 8 for the northwest corner of this tract.

THENCE S. 87° 11' 56" E., along the north line of said Section 8, at 30.00 feet pass a 1/2" iron rod with a cap inscribed "OJD ENG" (hereafter referred to as an OJD cap) set in the east margin of Leon Road, a total distance of 1324.25 feet to an OJD cap set for the northeast corner of this tract.

THENCE S. 02° 35' 24" W., at 276.32 feet pass an OJD cap set in the north right-of-way (R.O.W.) line of a private road, a total distance of 336.32 feet to the southeast corner of this tract.

THENCE N. 87° 21' 27" W., at 60.00 feet pass an OJD cap set in the west R.O.W. of said private road, at 1293.72 feet pass an OJD cap set in the east margin of said Leon Road, a total distance of 1323.72 feet to the west line of said Section 8 for the southwest corner of this tract.

THENCE N. 02° 30' 07" E., along said west line and said Leon Road, a distance of 339.99 feet to the POINT OF BEGINNING and containing 10.28 acres of land.
